

THE CORPORATION OF LOYALIST TOWNSHIP

BY-LAW NO. 2012-001

Being a By-law to amend By-law 2007-031 – Loyalist Township Parking By-law

WHEREAS the Municipal Act, S.O. 2001, c.25 as amended and the Highway Traffic Act, R.S.O. 1990 c.H.8 as amended authorize a municipality to pass by-laws to regulate the use of highways and bridges, to create and designate parking spaces, to prohibit parking on highways, municipal or private property, to designate fire routes, to prohibit parking or standing of motor vehicles and to provide for enforcement;

AND WHEREAS Loyalist Township Council adopted By-law 2007-031 to regulate the use of highways and bridges, to create and designate parking spaces and prohibit parking on highways, municipal or private property, designate fire routes, prohibit parking or standing of motor vehicles and to provide for the enforcement of the by-law;

AND WHEREAS Loyalist Township Council adopted By-law 2011-061 to amend By-law 2007-031 by revising Schedule ‘E’ which designated no parking areas on certain streets;

AND WHEREAS Loyalist Township deems it desirable to update Schedule ‘E’ to By-law 2007-031;

NOW THEREFORE The Corporation of Loyalist Township hereby enacts as follows:

1. That Schedule ‘E’ to By-law 2007-031 which regulates and prohibits parking on certain streets is hereby amended by Schedule ‘E’ attached hereto.
2. That By-law 2011-061 and any other by-laws or portions thereof conflicting with this by-law are hereby repealed.
4. This by-law shall come into force and take effect on the date of its passing.
