



BY-LAW 2011-069 – DOG CONTROL BY-LAW

2012 Dog Tag Sales

Loyalist Township residents are advised that dog tags must be purchased for all dogs in Loyalist Township
Regular Dog Tag rate is \$30.00

Dog Tags:

Between January 1 and March 31 every year - \$15.00 per dog tag (Discounted rate)
After March 31st every year - \$30.00 per dog tag (Regular rate)

Kennel Licences:

Between January 1 and March 31 every year - \$120.00 per kennel licence (Discounted rate)
After March 31 every year - \$220.00 per kennel licence (Regular rate)

**All residents are encouraged to buy dog tags as soon as possible
to avoid the additional penalty**

Other Requirements Under By-law 2011-069

Not more than a total of three (3) dogs shall be kept in or about any dwelling unit in a built-up area. (Definition of built-up area three (3) abutting residential properties each smaller than one (1) acre in size.)

Residents are reminded that the Dog Control By-law provides that any owner of a dog which defecates in a public place must clean up the droppings and dispose of it in a sanitary manner. There is a \$75.00 fine for this offence.

Dogs must also not be permitted to run at large at any time and must be on a leash when in a public park. There is a \$75.00 fine for this offence.

Dear Resident:

As you are aware, all dog owners are required to obtain a Dog Tag for each dog they own or keep on their property. If you are a landlord and have tenants with dogs, please pass this information to them.

The annual fee is \$ 15.00 per dog tag until March 31st each year (Must arrive in Office by March 31)
After March 31st each year, the rate is \$ 30.00 per dog tag. (no exceptions)

Please complete the attached form in full and either:

- 1) return in person to Loyalist Township Office, Odessa or W.J. Henderson Recreation Centre, Amherstview
2) or mail form with payment to Loyalist Township, 263 Main St., P.O. Box 70, Odessa, Ontario, K0H 2H0 . You must include a self addressed, stamped envelope , so that your new 2012 dog tag can be mailed back to you.
