

**THE CORPORATION OF LOYALIST TOWNSHIP**

**BY-LAW 2002-67**

Being a By-law to Establish Fee Schedule  
and Deposit to be Included with all Requests for Fenceviewers

WHEREAS Section 17(1) of The Line Fences Act, R.S.O. 1990, Chapter L.17 authorizes the Council of The Corporation of Loyalist Township to pass a by-law to fix its reasonable administrative fees to be paid to the municipality in relation to proceedings under this Act;

AND WHEREAS the Council of The Corporation of Loyalist Township adopted By-law 98-27 which included various fees that are now outdated;

AND WHEREAS the Council of The Corporation of Loyalist Township deems it expedient to revise the Schedule of Administrative Fees;

NOW THEREFORE the Council of The Corporation of Loyalist Township hereby enacts as follows:

1. A deposit in the amount of \$300.00 to cover all reasonable administrative fees, including fees for three Fenceviewers plus mileage, shall be included with any Request for Fenceviewers before any action is commenced.
2. Estimated Administrative Fees as detailed on Schedule 'A' attached hereto shall be considered the guideline for determining the deposit.
3. That By-law 98-27 and any and all by-laws or parts thereof conflicting with this by-law are hereby repealed.
4. This by-law shall come into force and take effect on the date of its passing.

5.	If the Fenceviewers determine an Ontario Land Surveyor should be hired to describe the location of a fence by metes and bounds then the applicant is required to pay a further deposit to be applied against total administrative costs incurred by the municipality.	
	This deposit will be based on the estimate provided by the Ontario Land Surveyor.	
6.	If the Request for Fenceviewers proceeds to the Appeal process then a further deposit to cover the Referee Appeal Fee will be required in the amount of the Referee Fee
