Statutory Public Meeting – Items under the Planning Act

Public Meeting – Housekeeping Amendments to the Loyalist Township Official Plan

The purpose of Amendment No. 42 to the Official Plan is to make various housekeeping amendments to the Official Plan. It also will implement changes to the *Ontario Planning Act* that were made through Bill 13, *Supporting Businesses and People Act*, 2021, which consists of new policies pertaining to delegated authority for minor zoning by-law amendments. The amendment applies to the entire area of Loyalist Township.

Appointments

Council appointed Justin James to the Committee of Adjustment and the Appeals Committee and Cory Grant as Tile Drainage Inspector.

Items for Consideration

Council approved the following items:

- Councillor Proderick and Deputy Mayor Townend are approved to attend the <u>Federation of</u> <u>Canadian Municipalities (FCM) Conference and Trade Show</u> in Calgary, Alberta between June 6 to 9, 2024
- With the approval of the 2024 budget there was amendments to the <u>Miscellaneous Fees and Charges By-law</u> which include fee changes regarding Freedom of Information requests, Notarization Fees, Lottery Licensing Fees, Fire Permits, Bag Tags and Recreation Field and Facility Rentals. <u>By-law 2024-32</u>
- Approved amendments to <u>Tile Drain Loan</u> for a local farmer to assist with the construction of tile drainage works to property located at 1538 County Road 5. The loan will be total sum of \$21,000 to be repaid with interest.

- Property Standards and Safe Properties By-laws will now be in line with the Resilient Climate
 Action Plan, addressed Council Resolution 2023.15.19 and will improve the administration of
 the various by-laws by reducing duplication. The Safe Properties By-law will also allow for the
 creation of more pollinator friendly areas across the Township and restrict nuisances such as
 noxious weeds and excessive growth impacting neighbouring properties. The Property
 Standards By-law derives from the Ontario Building Code Act while the Safe Property by-law
 derives from the Municipal Act.
- <u>Lakeside Phase 6 Plan of Subdivision and Lakeside Phase 2 Stage 5 Plan of Subdivision-Assumption of One Foot Reserves.</u> The reserves are no longer required due the registering of the Lakeside Phase 8 Stage 1 Plan of Subdivision.
- RY Contractor Inc. and Legacy Homes Draft Plan of Subdivision (D12-310-2021), Official Plan
 Amendment (D09-002-2021) and Zoning By-law Amendment (D14-009-2021). The applications
 were in support of a proposed development located at 496 Main Street in Bath. The
 development proposal redesignated and rezone the lands from commercial to low density
 residential to permit a residential subdivision consisting of 18 semi-detached and 19 single
 detached units.
- Developer Agreement for Potter, Creighton, South, Main Street Odessa Reconstruction
- <u>Signage Options at County Road 6 and Taylor-Kidd Boulevard Roundabout</u>. The County of Lennox and Addington asked the Township to provide input into the design of the roundabout, particularly the opportunity for branding of signage proposed to be located on the retaining wall located in the middle of the proposed roundabout. Staff recommended to use Loyalist Township lettering in the retaining wall for the roundabout, similar to roundabout located in Morrisburg, Ontario.
