Public Meeting – Housekeeping Zoning Amendment

The proposed housekeeping amendment was initiated by the Township to correct zone map errors affecting one property in Odessa, four properties in Bath and three properties on Switzerville Road. The public meeting was to hear from any person who claimed to be affect by the application. A recommendation report will be brought forward at a future Council meeting.

Quinte Conservation Authority Presentation

Council supported, by resolution, the objectives outlined in the presentation being: approval, in principle, for the scope of Category 2 and 3 programs and services to be delivered by Quinte Conservation effective 2024; and direction to work with administrative staff on provincially mandated agreements.

By-law 2022-084, being a by-law to lift part lot control requirements for Lot 43, Registered Plan 29M-64 for the Babcock Mills Phase 3 Plan of Subdivision, was enacted and passed.
