Solid Waste Collection Contract Extension

Council authorized staff to enter into negotiations with Waste Connections to extend the existing waste disposal collection contract for two years, with an option to extend for one additional year. This contract extension would provide staff with an opportunity to conduct a review of how the Township currently manages its waste and how to manage its waste in the future in order to meet the 49% corporate greenhouse gas reduction goal set by the Township and the changes to the waste diversion program proposed by the province. The review would incorporate public and stakeholder engagement and a cost-benefit analysis of providing curbside collection of food and organic waste.

Renewable Energy Vibrancy Fund Advisory Committee Update

Council received the Renewable Energy Vibrancy Fund Advisory Committee Update report and adopted the Committee meeting minutes from the Dec. 18, 2019 and Jan. 16, 2020 meetings. Council also adopted the changes to the Terms of Reference for the Committee. Before supporting the policy framework presented in the report, a motion was carried to discuss the policy framework at greater length at the next Committee of the Whole meeting on March 2, 2020.

Community Bonfire

Council approved an exemption to By-Law 2015-050 for a period of 8 hours starting at 1 pm (13:00) on February 15, 2020. The exemption will allow firefighters at the Amherst Island Station to conduct a burn of clean, dry brush on Township property.

Loyalist East Business Park

Councillor Budarick provided a Notice of Motion at the Jan 27 Council meeting for consideration at the Feb 10 Council meeting. The motion resolved that Loyalist Council requests a report from the Economic Growth & Community Development department to maximize flexibility and minimize limitation on development of the Loyalist East Business Park while still protecting the Township against future liability and maintaining the development goals of that block of properties.
