52nd Session

Water Conservation Incentive Program

Council enacted a bylaw to establish a policy outlining the eligibility criteria and administrative requirements for the water conservation incentive program. This program will grant owners a \$50 credit per single family unit upon installation of a low-flow toilet or high-efficiency faucet. A determined budget will be set annually for this program as approved by Council. More information on the program is available at loyalist.ca/WaterRebate

2021 Draft Development Charges Presentation

Council received a presentation with draft development charges ("DCs") as calculated by Hemson Consulting Ltd. based on information provided by Township staff. Following the presentation, Council directed staff to work with Hemson Consulting Ltd. to finalize a draft version of the development charges background study for posting on August 26 as legislatively required. Council also directed staff to hold a virtual consultation session with stakeholders, and to advertise and hold a Public Meeting scheduled for September 27 to receive comments on the draft development charges study and by-law with the intent to adopt at the October 25th Regular Council Meeting.

Community Safety & Well-Being Planning Update

Council received a presentation from Upstream Communications regarding the status of the Community Safety & Well-Being Plan for Lennox & Addington County, Deseronto and Tyendinaga Township.

Operating, Capital, and Reserve & Reserve Fund Status

Council received a report from the Business Services Department with a 2021 second quarter update on operating and capital budget to actual review, along with updates on reserve & reserve fund balances.

Bath Pickleball Club Lease Agreement

Council received a report from the Recreation & Facilities Division, re: Bath Pickleball Club Lease Agreement, and Council approved a lease agreement for a term of one year, effective May 1, 2021 and ending September 30, 2021 at a rate of \$1,000 (inclusive of HST) per season with future renewals processed through the Perfect Mind facility rental system.

Agreement for Recycling, Processing and Marketing Services and Household Hazardous Waste Services - City of Kingston

Council received a report from the Public Works Division, re: Agreement to purchase certain Recycling, Processing and Marketing services and Household Hazardous Waste services - Corporation of the City of Kingston, and Council authorized an agreement between Loyalist Township and the City of Kingston which establishes the terms and conditions by which the Township will continue to purchase services from the City relating to recycling, processing and marketing of recyclable materials together with services related to household hazardous wastes.

Minor Amendments to the Procedure By-law will be presented at the September 13th, 2021 Council meeting for public comment.
