Planning <u>Public Meeting</u> 19 Main Street, Odessa - Zoning By-law and Official Plan Amendments, and Draft Plan of Subdivision

A public meeting was held in accordance with the *Planning Act*, R.S.O. 1990 to consider amendments to the Official Plan, Zoning By-law 2001-38, as amended, and a Draft Plan of Subdivision. The proposed Draft Plan of Subdivision consists of 286 single detached dwellings and 326 semi-detached dwelling units for a total of 612 lots, 3 parkland blocks, multi-use pathways connecting the development with Main Street (County Road 2) and expansion of an existing stormwater management facility. Council received the presentation from representatives of Fotenn on behalf of the applicant and the staff report that recommendations will be brought forward to Council once the comments from the Township departments, agencies and the public have been addressed.

Delegations and Presentations

Amherstview West Secondary Plan Update

Loyalist staff and representatives from WSP provided Council with an update on the Amherstview West Secondary Plan. Council received the presentation for information.

Municipal Noticeboard Policy

Council adopted the Municipal Noticeboard Policy as amended (sections 3.1, 6.2 and 6.3) which establishes guidelines and provides a consistent and uniform process for community groups to request the use of Township noticeboards and formalizes the procedure for requests.

Draft Plan Approval Extension - 2446830 Ontario Limited - Lakeview Subdivision

Council received and approved a request for an extension of draft plan approval for Lakeview Subdivision, with conditions, the change to the conditions were deemed to be minor.

Loyalist East Business Park - Development Permissions

Council approved the Loyalist East Business Park - Development Permissions and that staff bring forward proposed amendments to the Township's Official Plan and Zoning By-law pertaining to employment areas once the new Provincial legislation and policies are in effect.
