#### **Acquisition or Disposition of Land**

Council authorized staff to proceed with the proposed land transfer with Limestone District School Board and to request the transfer for a road widening along Durham Street to address any possible future intersection improvements in the area.

## New Fire Chief and Deputy Fire Chief

Council appointed Kent Readman as the Fire Chief and Mike Greenham as the Deputy Fire Chief for the Loyalist Township Fire Department. Council congratulated both.

# **Budget 2024**

Council approved the 2024 Budget as recommended by the Committee of the Whole.

## Statutory Public Meeting – Items under the *Planning Act*

Public Meeting <u>- Kaitlin Corporation (2238052 Ontario Ltd.) Phase 15 Draft Plan of Subdivision (D12-041-2023) and Zoning By-law Amendment (D14-019-2023).</u> The proposed amendments apply to a proposed subdivision municipally located at the corner of Main Street and Country Club Drive in the Village of Bath. Angela Sciberras and Rodrick Sutherland, Consultants for the proponent provided an overview of the proposal via a PowerPoint presentation. Several members of the public provided comments regarding the application.

# Request to Purchase Closed Road Allowance - Road Allowance between Lot 19 & 20 Concession 2 Closed by LA162597 between Millhaven Road and CN Rail

Council authorized staff to proceed with a request to sell a portion of the closed road allowance described as Road Allowance between Lot 19 & 20 Concession 2 Closed by LA162597 between Millhaven Road and CN Rail in accordance with Township Policy and in addition to the requirements of Township By-law 2004-33, Being a By-law to Establish Procedures Governing the Sale of Real

Property with the intent to deem a portion of the road allowance surplus and sell to the abutting property owner, an appraisal be obtained and the sale price be based on the appraised value.
